## District Welcomes New Board Member— Legislator Christina Bove

## Emergency Watershed Protection in Response to August 2009 Storm Damage and Flooding

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) administers the Emergency Watershed Protection (EWP) Program, which responds to emergencies created by natural disasters. EWP is a recovery effort intended to relieve imminent hazards to life and property caused by floods, fires, windstorms or other natural occurrences. With the exception of the EWP floodplain easement option, EWP projects must have local sponsors. NRCS may cover up to 75% of the cost of eligible construction work associated with restoration activity (90% within limited-resource areas as identified by U.S. Census data). Remaining costs must be covered by local sources and can be cash and/or in-kind services. Funding for the program is provided through congressional appropriations.

Authorized work includes but is not limited to:

- Clearing debris-clogged stream channels
- Repairing eroded and unstable streambanks
- Protecting jeopardized water control structures and public infrastructure
- Establishing permanent easements on floodplains to restore floodplain functions (and eliminate future cropping or development)

More than 25 eligible project measures are in the design, contracting and construction phases in southern Erie County, and northern Chautauqua and Cattaraugus Counties in response to the unusually severe storms and flooding of August 9 & 10, 2009. Once an EWP project is approved, that work becomes a top priority activity for local staff and, typically, additional personnel are brought in to help as well. Already, local engineering staff has been supplemented with the assistance of personnel from Batavia, Geneseo, Warsaw, Syracuse, and Florida and Montana. All work is expected to be completed by September 30, 2010. Federal EWP assistance is estimated to exceed 5.5 million. It's going to be a very busy summer. 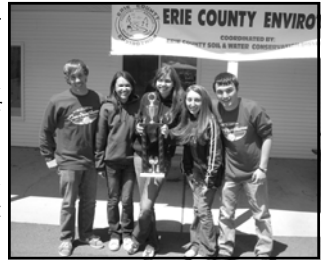

## Grazing and AEM could be the solution for you!

Hard economic times are nothing new to northeast farmers. NYS farmers have been struggling with decreased revenues (ex. milk and beef prices) and inflated input costs (ex. grain and fuel) for years. During economic hardship, farms like any other business evaluate their situation and restructure to become more efficient. One solution to efficiency that livestock farms in the northeast have started to adopt is intensively managing pasture as a source of forage. The utilization of pasture by livestock farms is nothing new, however, it is a practice that has historically been underdeveloped as it was cheaper to mechanically harvest crops.



Many farmers of the northeast are changing the way they utilize their pasture and hay fields. Intense Rotational Stocking (IRS) also referred to as rotational grazing or prescribed grazing is a method of managing both livestock and pasture resources to cut cost and maximize profits. The fundamentals of IRS are dividing large pastures into smaller units (paddocks) based on carrying capacity, and rotating livestock through the paddocks at specific times to maximize forage production and nutrient content, while maintaining plant health and vigor.

IRS has a lot of attractive benefits such as decreased labor costs, cull rates, herd health costs and increased net return per cow and a higher net return per acre than other forages such as hay or corn silage. The key to realizing the maximum benefits of IRS is the level of management applied to the system.

IRS is just one of the suite of practices that can be planned and implemented with the Agricultural Environmental Management (AEM) program. AEM is a locally lead, voluntary, incentive based program that helps farmers operate environmentally sound and economically viable businesses. Through the AEM program ECSWCD can collect and hold in confidence, farm specific information that is used to develop a conservation plan to complement the existing environmental stewardship being done by the farm. AEM can be utilized by any large or small agricultural operation of any kind including but not limited to, equine, livestock, poultry, and fruit/vegetable farms. ## Summer Fish Stocking

The District's annual fish stocking program for pond owners will take place this July with the scheduled fish distribution on Saturday July 24th at 10am in the District parking lot at the East Aurora field office.

Orders for Largemouth Bass fingerlings and Fathead minnows are currently being accepted. New to the program this year, Grass Carp are also being offered as a biological method to help reduce widespread aquatic vegetation in ponds.

To stock Grass Carp a special permit is required from the NYSDEC. If you plan on purchasing Grass Carp, make sure you get the permit application in weeks before the fish distribution as you will be required to produce the permit to pickup your fish. Also don't forget, a general pond stocking permit from the NYSDEC is necessary to stock pond fish. Both applications are available at the District office. All fish will be provided in cool water, oxygenated bags to make transport a simple process.

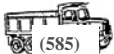

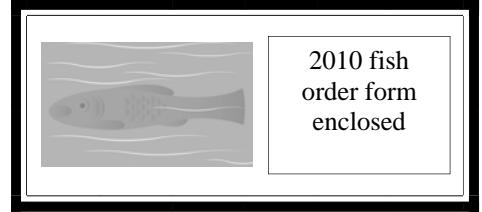
